

**#HERSHEYPARK2018 SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN.

Hershey Entertainment & Resorts Company (“HE&R”) presents #Hersheypark2018 Sweepstakes (“Sweepstakes”). If this Sweepstakes is promoted or administered on Facebook, Twitter, Pinterest or any other social media platform (collectively “Social Media Platforms”), entrants understand that it is in no way sponsored, endorsed or administered by, or associated with those Social Media Platforms. Entrants understand that they are providing their information to HE&R and not to any Social Media Platform. The information provided will only be used for the purposes of the Sweepstakes and as otherwise expressly agreed to by each entrant, subject to HE&R’s privacy policy. HE&R reserves the right to discontinue the Sweepstakes without notice for any reason and to modify or extend the Sweepstakes Period, as determined in its sole discretion.

1. ELIGIBILITY. One (1) Grand Prize winner will receive four (4) Regular Hersheypark Season Passes for 2018 (visit www.hersheypark.com for details on hours of operation), four (4) Hersheypark meal vouchers, ; one (1) Cabana rental at The Boardwalk At Hersheypark; one (1) Boardwalk Beach Bag (contents to be determined by HE&R); The approximate retail value of the Grand Prize is \$1071.40.

Four (4) Runner-Up Prize winners will each receive four (4) regular one-day admission tickets to Hersheypark Amusement Park valid for the 2018 summer operating season. The approximate retail value of each Runner-Up Prize is \$259.40.
